

## City of Elkins, Arkansas City Council Meeting


TIME: 7:00 p.m.

5. Approval of 1-21-2010 minutes- Alderman Stevens made a motion to approve. Alderman Miller seconded. Roll Call: (5/0) Motion Carried.
